On the one hand, the decrease of the light constant is so minimal that it hardly matters in 10 billion years, because in fact it has to be calculated in trillions of years in this respect. And just this says that the calculations of the earthly astronomical sciences are in no way correct - as also many other of their claims are not - that our DERN universe is only between 12 and 18 billion years old. In fact, it is already 46 trillion years old, calculated from the time when the really original big "bang" shook everything and gave birth to the creation, the universe resp. the universal consciousness. Thereby, seven different belts and/or levels of the universe came into being, of which the matter-belt is the one, respectively embodies the part of the universe that earth-mankind calls the real universe, but does not really know in any way. The few things that astronomical science knows or believes to know about it, is an extremely tiny part, which is hardly worth mentioning, even if the scientists think that they have discovered and created a lot of knowledge. The idea that the universe consists of seven different belts, in which the visible material universe represents only a seventh of the whole, whereby this part of the universe - as well as the other six belts - is constantly expanding and is subject to continuous change.

Now however back to the actual question, to which however the proceeding to the explanation was necessary, in order to create some understanding: A light year is equal to 9.4605 trillion kilometers. The light year is a unit sign for a unit of length used in astronomy, for the distance that light travels in a vacuum in one year. So 1 light year = 9, 4605 x 10 to the power of 12 km = 0.3066 pc (parsec). And if now an object, a galaxy, a nebula, a star resp. a sun etc. is 10 billion light years away from the earth, then this means a distance of 10 billion x 9, 4605 trillion kilometers. And if an object is 10 billion light years away from the earth, this means that the light from the mentioned object has to travel 10 billion years until it can be perceived from the earth. But this means that the object, when its light can be seen on earth, maybe has already passed and disappeared because it has dissolved in the course of the unstoppable cosmic change.

## Sighting Report

(Telephone call, 13 April 2002, 21.46 h and 22.13 h, in the presence of Madeleine, Hans-Georg and Freddy) Mr. Meier, I know you on the one hand by sight and on the other hand through television reports, newspaper reports and journal reports. About three months ago there was also a report about you in a Thur- gau daily newspaper. But the reason why I'm calling you today for the first time is that we first had to think long and hard about whether we should say anything at all about what I want to tell you now. In addition, and this is actually the main reason why I am only telephoning you today, I and my two companions first had to process our experience to such an extent that we can understand what we actually saw with our own eyes. In addition I would like to tell you, Mr. Meier, honestly that we never believed in UFOs and thought of you that you were a nutcase. And honestly ge-

says, we thought other things about you. Today we are very sorry for that, because through our experience we have gained a different picture of you, so that today we are of the opinion that the things are true which you tell and which are told about you, written and brought on television. But now I want to come to the reason why I am still calling you at such a late hour:

It was on 14 March, three weeks ago. When I drove in the early morning, coming from Dussnang/ TG over Sitzberg and Schmidrüti, about 6.10 o'clock together with a work colleague and my brother in my car to work in the Zurich Oberland, we saw a rather strongly yellowish-white glowing, large, disk-shaped UFO, which flew in only about two hundred or three hundred meters height from the south over the army plant of Schmidrüti toward the north. In order to be able to observe the UFO better, which we estimated at a size of at least five meters, we stopped at the left turn on the hill above Schmidrüti, from where one can look down on a large wood yard and on a biotope, got out of the vehicle and determined, We got out of the vehicle and noticed that there were no sounds of animals and no noise from the object, which suddenly lost altitude and seemed to crash into the Hinterschmidrüti farmhouse, shining brightly and then suddenly disappearing without us being able to see or hear anything. At first we actually thought that the UFO had crashed, so we climbed over the gate on the hill of the Hinterschmidrüti farmstead and ran forward to have a look. But apparently everything was in order, because the homestead stood intact in its place, and there was nothing more to be seen of the UFO. Do you have an explanation for this, Mr Meier, because firstly you deal with such things, and secondly it was the house of the FIGU association, where you also live, over which the UFO fell and disappeared so suddenly. Unfortunately, we cannot talk to anyone in our circle of friends and acquaintances about our experience, because with everyone we know we would only make ourselves ridiculous, as we know from earlier observations, when such things were discussed. But since we still cannot really cope with and understand what we have experienced, despite all our efforts, not even our wives, to whom we have of course told everything, we would like to talk about it with you. However, we do not dare to come to you in Hinterschmidrüti, which is why we would like to talk about everything with you at our home, or somewhere in a restaurant, if we could meet at a certain place. We would be very grateful for that.

In the proof of the true contacts of 'Billy' Eduard A. Meier to the Pleiars, besides the photos, witness reports, metal samples, sound recordings etc. also prophecies and the old predictions of future events play an important role. A whole book is dedicated to this subject with the title: 'Prophecies'. During the years I often witnessed how the predictions and prophecies of the Plejaren proved to be correct with high precision. An accuracy that I have learned to fear in certain aspects and in a certain way. Prophecies are changeable and depend on the change of human minds. We have worked out probability calculations that the whole thing will happen in Japan, in the sense that spinach plant genes will be transferred into pigs.

In fact, on January 25, 2002, the following could be read in an article of the 'Tages Anzeiger':

**Spinach pigs.** *Japanese have implanted a spinach gene into pigs. The spinach meat would probably be healthier than normal pork, said a genetic researcher. Whether it would be as healthy as spinach, however, could not yet be said.*

So, once again, a Pleiadian prediction made exactly 15 years ago has come true with absolute accuracy.

In this case it is a prediction concerning scientific matters. It becomes more disturbing when the prophecies and predictions speak of political upheavals and catastrophes. During the same conversation in February 1987 Quetzal also said the following:

## **Law against clitoral circumcision or tradition of inhumanity at least on paper in the pillory !**

According to a newspaper report in the Schaffhauser Nachrichten of Thursday, 13.12.2001, genital mutilation of girls under the age of 17 is to become generally punishable in Kenya. The new law shows some progress on the African continent, because in 1996 a ban on genital mutilation did not even reach parliament. The law, which is now before President Arap Moi for his signature, also provides for clitoridectomy of older girls and women to be subject to consent. Unfortunately, the removal of the clitoris and even the amputation of the labia minora are still part of the ritual of becoming a woman in many places. A ritual that testifies to the unwritten oppression, disregard, enslavement, deprivation of freedom and servitude of women and girls. As a product of cult-religious confusion and delusional ideas this inhuman custom shows with all clarity with which power and violence the ruling male world forced and forces the humility of their women.

Jealousy, lust for power, possessiveness, sadism and degenerated sexual fantasies and thoughts are the motives behind such shameful acts. No creative law and no single commandment demands to mutilate the genitals of women or to harm them in any other way. There are no such degenerated examples in nature that can be transferred to humans.

Traditions do not protect from folly and error. Therefore, it is inexcusable to inflict such terrible torment and abuse on innocent girls and women in the name of tradition, tribal custom or alleged proof of maturity. Countless girls and young women have lost their lives after circumcision and have perished miserably from poisoning and infection.

The mothers, all women and women capable of giving birth are the mirror of creative existence through a birth. Hardly any other tradition breaks more with the creative laws than the abuse, contempt or mutilation of a creative act.

Creation itself begets, creates, and gives birth with joy, thereby fulfilling the highest evolutionary purpose and meaning of existence. It does not destroy itself in creative work and does not surrender into self-imposed restrictions, dogmas and cult-religious falsehoods. It does not correspond in any way to the plan of creation to create an organ of pleasure for women and girls in order to mutilate it painfully afterwards as a confirmation of fertility or proof of becoming a woman. Pleasure sensation and joy also belong to the law of creation.

The act of procreation is like the pain of birth, which is naturally followed by the joy of the newborn life. If all this were different, then creation would not have created a clitoris for women if this organ did not have a very specific task and function to fulfil according to the laws of creation.

In contrast, however, male circumcision has a completely different and hygienic function. It does not reduce the pleasure sensation and is limited only to a small piece of foreskin of the glans. The man does not have half or all of his penis cut off, as is basically done to women by circumcising the labia and clitoris in an inhumane manner and in the name of tradition. No man would voluntarily and out of tradition have his penis removed in order to do without pleasurable sexual activities for life in the name of false traditions. But this is exactly what the men's world of certain world regions demands under threat of violence against women.

However, signing alone will not solve this problem, Mr Arap Moi. The implementation and enforcement of this law requires a change of thinking and a change of consciousness in people. It requires courage to criticize and destroy old and anti-life traditions. Signing requires courage to stand up for the rights and equality of women. True tradition is therefore found in following creative laws and commandments and in respecting and honoring both sexes.

On 17 December, the Tages-Anzeiger published another interesting article on the subject of women's rights: In Turkey, a week earlier, women employed in state offices, school classes and post offices appeared in trousers as an exception during a protest. State dress regulations prohibit women in the public service from wearing trousers. The Turkish parliament then drafted a new dress code. But rules still exist. Fingernails must be short, skirts must reach above the knee. Wide necklines are forbidden, as are blouses without sleeves. Sandals remain forbidden on the feet and a scarf still belongs on the head. But even in the choice of trousers there are still taboos: jeans and stretch pants are not allowed.

Conclusion: Actually many of the men are the quite obviously really poor and weak creatures. They are obviously without prohibitions, flimsy traditions and pseudo-religious moral codes neither capable nor able to get their greed, lechery and weakness through their own thought control under control.

Beauty and grace of women are a psyche-forming, psyche-enriching and psyche-building factor. But where beauty, grace, freedom and femininity are forbidden, ultimately the psyche withers and the humanity is miserably lost.

Therefore, Earthman: It is gradually time for you to exercise reason and live in harmony with the female sex. You will not lack wise teachers if you turn to them, grant them their honor and rights, and grant them equality and equal rights.

## **overshooting the mark**

For quite some time now, numerous science fiction authors and science fiction filmmakers have been competing with their inventiveness with regard to their exciting time travel stories of all kinds. There is nothing wrong with that, quite the contrary, but sometimes they overshoot the mark with their speculations. With the regularity of a Tibetan prayer wheel it is propagated that time travellers could influence and even change anything in the past at will. Such information, spread either out of ignorance or for sensational reasons, does not correspond to reality at all. In the representation of such interventions in the past a

But the most important factor is totally overlooked, namely that everything that has already happened historically cannot be changed afterwards under any circumstances.

1. Example: Is it possible to preserve valuable scrolls in the past from eternal destruction?

Let us assume that extremely valuable scrolls, which are of eminent importance for the whole of mankind, were found in Greece in the year 1000. But 10 years later they were totally destroyed by a fire. In the year 2000 a temponaut comes up with the glorious idea to save this precious cultural asset from eternal destruction by means of a time jump. If the burning is already a fait accompli it can't be undone anymore. In principle a rescue is only possible before the burning. So, somebody would have had to appear in Greece within the 10 years between 1000 and 1010 in order to secure the said scrolls. But unfortunately this opportunity was missed - otherwise they would not have been burned - and now what was missed can never be made up for. So the temponaut mentioned has absolutely no chance anymore and will never get it in the future.

2. Example: Could World War II have been prevented?

Sometimes voices are raised that one could have prevented the world war by eliminating the main responsible. Theoretically, it would have been quite possible to carry out an assassination attempt on Hitler, but - and this is again the crucial point - it would have had to happen in any case before the outbreak of the war. The fact is, however, that at no time at all did an assassin show up at the dictator's house to kill him. Nothing can be done about this after the fact. It would be a real paradox if the Second World War, which unfortunately took place, could be undone afterwards. By the way, we could find out from a reliable source (Ischwisch Quetzal) that the leader of the Third Reich actually committed suicide at the end of the war, which was denied by certain circles. Incidentally, as far as I know, the public never heard a word about his fatal illness, which would have taken him away quite soon anyway.

3. Example: mother-son paradox.

And what are we to make of a son who travels back in time and accidentally sends his mother to the afterlife before he is born? The case is quite clear. It can't happen at all. Without a mother the birth of the son doesn't take place - therefore he isn't existent at all and can't travel through time to kill the mother. Theoretically, the mother could be killed by her son several years after his birth, unintentionally or on purpose - but as said theoretically. With intention this atrocity surely couldn't be carried out for the following reasons: As far as a human being is able to travel through time, he will usually not even dream of doing anything that would mean an unauthorized intervention into the course of events. But if, contrary to expectations, his logical mind and his reason are not as well developed as one would expect them to be, then eternally valid laws of nature will surely make sure that no gross violations can be committed. Fortunately, nature is equipped with a safety mechanism, which

always and everywhere has the necessary measures ready, if this is necessary. In connection with the aforementioned matricide one can imagine, for example, that the son is suddenly plagued by his bad conscience and therefore does not want to carry out the malicious deed after all - or having arrived on the spot he suddenly forgets what he actually intended to do - or he does not find his victim at the place of the past - he perhaps loses his murder weapon on the way - or his firearm has a jam at the decisive moment, etc.

For time travellers there is absolutely no chance to influence the natural course of history in any way, so that irregular circumstances can arise that could have catastrophic consequences (because, apart from the theories mentioned, reality also exists as it is described by Billy in the following article). Thus, the inviolability of historical events is guaranteed in any case and at any time and place. ### or: Cult religion and science in contradiction!

According to the biblical doctrine of creation, the first man 'Adam' was created by God himself in the Elysian Gardens between the Euphrates and Tigris rivers about 5000 years ago. The first woman, Eve, was also created from Adam's rib. Allegedly, on the sixth day of his creative work in his workshop, God set about creating mankind (Bible Genesis 1, ch.1, verse 26 ff.).

At least this is how this legend was and still is taught to the children in many schools as 'Christian truth' (a detailed article on this subject has been published in the FIGU magazine 'Voice of Aquarius Time' No. 102 of March 1997 under the title 'Vom biblischen Schöpfungs-Mythos und dem Unsinn der biblischen Schöpfungsgeschichte oder Erstes Buch Mose, Genesis' (On the Biblical Creation Myth and the Nonsense of the Biblical Creation Story or First Book of Moses, Genesis) by Hans G. Lanzendorfer (concept) and 'Billy' Eduard A. Meier (execution)).

In the recent past a hot discussion has flared up again among scientists concerning the topic 'creation of man'. A controversy that is presumably observed and followed with suspicion by the church superiors, pastors and priests. Once again, in fact, the daily press is reporting: Researchers have found a six million year old skeleton of a pre-human in Ethiopia. Now a new dispute about the human family tree is breaking out among the scientists.

guessed. The researchers allegedly found a number of arm and leg bones, a lower jaw including some teeth and parts of the collarbone. The researchers around Yohannes Haile-Selas claim to have found the oldest human ancestor to date and date it to an age of around six million years.

At the beginning of this year, however, a French-Kenyan team also announced the discovery of the six-million-year-old "Millennium Man", which they claim to have found in the Tugen Mountains, 250 kilometres northwest of Nairobi. This fact contradicts the biblical doctrine of creation mentioned at the beginning of this article. The decision whether one or the other bony erratic block is possibly Adam must be left to the Pope and his imagination.

From a purely scientific point of view, these finds hardly cause a stir among the world's population. From a philosophical and theological-religious point of view, these two findings raise profound problems, at least for the Pope and his church. The central question is therefore simply: Did the Bible get it wrong after all?

"Of course not, because the world mysteries of this kind are in the plan of God..." will now be the voices of cult-believing Christian people. Understandably so, for an admitted error of the Bible would logically have fatal consequences for all Christendom. Especially for the papal chair, whose legs are already eaten by the woodworm and which is wobbling threateningly.

"Of course I do...!", I therefore raise my argument.

The facts are simple and obvious. People who believe in the Bible assume that heaven and earth were created by their God about 5000 years ago. Newer definitions state that this year should of course not be seen so narrowly and that the days mentioned can also be millennia. But already the fact that the Christian people can only rely on interpretations, opinions, views and on the contradictory statements of their 'scholars' and 'theologians' makes it clear that it is probably about a rather imperfect evolutionary tradition of their God that is in need of interpretation.

To make matters worse, there is not a single mention of possible ancestors of Adam in the entire biblical work. The Bible certainly does not allow for dinosaurs or any primordial animals. Interestingly, in the face of the anthropology problem, the excuse has never been made that Adam may well have been the first 'perfect' man created by God. Neither has the excuse that Adam, after many millions of years of practice, finally represented the first satisfactory product of God. Quite in the spirit of the old sayings of life: 'No master has yet fallen from heaven' or 'Practice makes perfect'. Of course this must not be the case. The Christian people want to see their God as perfect, all-knowing and all-capable. Mistakes are foreign to him. Moreover, he never started small either. Nevertheless, the riddle of the millions of years old history of the earth remains unsolved from the biblical point of view. So the question also arises why God waited for more than seventy million years after the extinction of the dinosaurs before he supposedly sent his son 'Jesus' (Immanuel) to earth two thousand years ago? Not to mention the fact that scientists - in stark contrast to the papal teaching - estimate the age of our universe to be around eight to twenty billion years; scientists who nevertheless stand moved next to the pope and look at the stars together with him through the Vatican telescope. Basically, it is an extremely paradoxical situation, whereby it is astonishing that the Pope can even take a look at something that, according to biblical teaching, that is, according to the dogma of his Church, is actually not possible.

Evolution would hardly have managed to create a universe several billion years old in the course of only five thousand years - yet it exists. According to Pleiari data, the universe is also already about 46 trillion Earth years old.

Conclusion: It is quite obvious that neither science nor the pope express themselves about this contradiction. Adults are silent about a serious philosophical contradiction. To hold one's hand over one's mouth and to remain silent shows self-abasement, blind obedience and self-imposed humility towards an erring power and institution. To want to remain contradictory is a matter of personal self-responsibility of each individual. However, to deliberately teach contradictions and illogic to one's descendants and children is already a sign of unscrupulousness. Nevertheless, the fact remains that ancient skeletons and countless other witnesses of a millions of years old history of the earth testify to the error of the biblical traditions. So it is only to be wished to the earthly humanity, but above all to its consciously blinded children and children's children, to wake up as soon as possible from their twilight sleep, to open their eyes and to throw a glance out into the space of the world. There, in the infinite expanses of the universe, neither a Christian Creator God, nor religious gods, nor any other cult religions, nor saints, nor angels, nor fate-determining powers and forces are to be found. Only and only a perfect creation, because: Creation with its laws is the most elemental, greatest power man can imagine. It is the being and non-being of the whole life in the universal space and far beyond. It is the most immense mass of spiritual energy that can exist in the whole universe. It is purest spirit, purest light and purest Sohar in purest form and unmeasurable in its wisdom, in its knowledge, in its love, in its truth and in its logic. The spirit is the essence of the energy of creation and of creation itself. The all-becoming and all-creating and all-living. The absolute, the primal energy of all being. (Quote: 'Billy' Eduard A. Meier).

# Ausserirdische lieben Vancouver

*Vancouver ist die Stadt mit den meisten Ufo-Sichtungen der Welt. Überhaupt scheinen Ausserirdische Kanada zu mögen.*

Wer schon immer eine Begegnung mit Ausserirdischen erleben wollte, reist am besten in die kanadische Stadt Vancouver. Das riet wenigstens die britische Zeitung «The Guardian» ihrer Leserschaft. Denn Vancouver sei angeblich die am häufigsten von Weltraum-Beobachtern besuchte Stadt der Welt.

Überhaupt scheint die Provinz British Columbia (B. C.), in der Vancouver liegt, ein äusserst günstiger Ort zu sein, um Ufos zu sich-

ten. Nirgendwo in Kanada melden so viele Menschen, dass sie ein Ufo beobachtet hätten, wie im Westküstenstaat. Das zeigt eine Liste, die der Wissenschaftsautor und Hobby-Astronom Chris Rutkowski von der Universität of Manitoba vor ein paar Wochen veröffentlichte: Ein Drittel der 374 Ufo-Sichtungen des vergangenen Jahres in Kanada fanden in B. C. statt. «Hier gibt es riesige Waldflächen und unberührte Wildnis», erklärt Gavin McLeod vom Verein «UFO\*BC»: «Vielleicht ist das ein guter Ort für Ausserirdische, um sich zu verstecken.» Auf der Internetseite von McLeods Verein ([www.ufobc.ca](http://www.ufobc.ca)) werden seit Jahren Berichte von Menschen in B. C. gesammelt, die Ufos oder Ausserirdische gesehen haben wollen.

Die Kanadier sind gegenüber solchen Phänomenen sehr aufgeschlossen: Nach einer Umfrage aus dem Jahr 1996 glauben 70 Prozent aller Kanadier, dass intelligentes

Leben irgendwo im Universum existiert. Davon glaubt wiederum die Hälfte, dass die Erde bereits von Ausserirdischen besucht wurde.

Laut Chris Rutkowski steigt die Zahl der Ufo-Berichte jedes Jahr an: Im vergangenen Jahr waren es 42 Prozent mehr als im Vorjahr. Im Dorf St. Paul in der kanadischen Provinz Alberta hat man sogar eine Landefläche für Ufos gebaut, direkt neben dem Gebäude der Handelskammer.

## Alle haben das Gleiche gesehen

Von einem Ufo-Vorfall, der sich mit angeblich harten Fakten belegen lässt, berichtet der Ufo-Experte Palmiro Campagna in einem Buch: Im November 1975 meldeten verschiedene Bürger in der Provinz Ontario, sie hätten Ufos gesehen. Auch Polizeibeamte sahen die mysteriösen Flugobjekte und erstatteten dem kanadischen Verteidigungsministerium Bericht darüber.

Die Sichtungen fanden in der Nähe eines Ortes namens Falconbridge statt, wo sich eine Radarstation des Nordamerikanischen Verteidigungssystems (Norad) befand, die den Himmel nach ungewöhnlichen Flugbewegungen absuchte.

Sechs Militärbeamte in Ontario gingen nach draussen und sahen drei Ufos durch ihre Ferngläser. Auf dem Radarschirm konnten andere Militärs sehen, dass ein Objekt in wenigen Sekunden von 8000 auf 22 000 Meter Höhe stieg. US-Kampfflugzeuge wurden ausgesandt, aber das Ufo war schon verschwunden. «Alle sahen dasselbe Objekt: der Radar, die Militärs und die Polizeibeamten», sagt Campagna: Er glaubt, Kanada brauche unbedingt eine seriöse Untersuchung solcher Phänomene.

## Cloning

What was to be expected has now become reality: The earthly science of human cloning has not yet progressed to such an extent that it is possible to act in this direction with a clear conscience and responsibility, when in Italy the doctor Severino Antinori goes public and spreads the word that he has already included a woman in his cloning program and that she is already heavily pregnant. And all this probably just to be the first to officially create a human clone. Perhaps this human cloner has imagined as a model the Jewish Golem (a formless mass), a mute human being formed and created from clay or mud, according to Jewish legend, which is supposed to possess enormous size and power and to appear as a savior in times of persecution of the Jews. Besides, it is probably the case that the Italian doctor wants to throw the very first human clone product "on the market" in front of the cult guru Claude Vorilhon, because in fact the whole thing is about nothing else than, on the one hand, big business and immense profit in the form of human trafficking, if everything is considered correctly, and, on the other hand, about megalomania in the way of being the very first human being to bring about the first human cloning. But the fact that the human cloning technique is still in its infancy and that not enough experience has been gathered in this respect does not bother crazy, megalomaniac and irresponsible people to already start with inhuman and criminal experiments of which one cannot yet imagine the consequences. No matter whether it is the doctor Antinori or the sect bigot and Elohim-Cicerone Claude Vorilhon: An evil contempt of human dignity and human rights is in any case given in a human cloning in the form in which such a cloning is handled by the two for profit purposes. This is quite apart from the unbelievably false and every reasonable person shocking unrealistic ideas and claims of the cult chief Vorilhon, who promises suffering people the blue of heaven, whereby they will have false hopes and then experience a cruel and evil disappointment when the clone-being promised to them should actually be created and then in no way corresponds to their wishes and expectations,



# Guru Raël im Klonrausch

*Der Arzt Severino Antinori soll einen Embryo geklont haben. Der Guru der Raël-Sekte liefert ihm ein Rennen. Ein makabrer Kampf um Ruhm und Geld.*

Um die Trophäe des ersten Menschenkloners machen der 57-jährige italienische Arzt Severino Antinori und der 56-jährige Guru Claude Vorilhon alias Raël einen viel beachteten Wettlauf (TA vom Montag). Am vergangenen Wochenende «punktete» Antinori. Er verkündete, eine Frau in seinem Klonprogramm sei in der 8. Woche schwanger. Details verriet er aber nicht. Doch in vielerlei Hinsicht ist Raël der gefährlichere Menschenkloner. Dem Führer der Ufo-Sekte macht es sichtlich Spass, die Öffentlichkeit laufend mit Horrormeldungen zu schockieren. So versprach er beispielsweise einem amerikanischen Ehepaar, die zehnmönnatige Tochter, die bei einer Operation gestorben war, in Form eines Doubles bis spätestens Mitte 2002 ins Leben zurückzuholen. Der erste Menschenklon müsste also längst im Fruchtwasser einer Raël-Anhängerin strampeln oder uns auf allen TV-Kanälen entgegenlachen. Doch der Fahrplan ist durcheinander geraten.

## Kranken Millionär klonen

Statt die Verzögerung zu erklären, flüchtet sich der Guru in neue Ankündigungen. Seine Wissenschaftler würden einen todkranken 59-jährigen Millionär von seinen Todesängsten erlösen und ihn klonen, erklärt er nun vollmundig. Der reiche Amerikaner solle selbst miterleben, wie sein genetisches Double als Baby aus dem Bauch einer Sektenanhängerin krieche. Dabei wissen auch er und seine Klonhelfer, dass sie aller Wahrscheinlichkeit nach 50, 100 oder mehr Embryonen verschleissen müssen, um ein Baby ohne Missbildungen zu produzieren. Sollte das Unterfangen überhaupt gelingen. Solche Versuche kann sich nur ein Guru leisten, der über einen Harem von hörigen Anhängerinnen verfügt. Schon haben sich 50 Frauen bereit erklärt, ihre Gebärmutter zur Verfügung zu stellen.

Die Ankündigungen des Gurus haben die Konkurrenz auf den Plan gerufen. Wissenschaftler in Italien, England, Australien und den USA machen ihm das lukrative Feld streitig. Doch die Hürden sind beträchtlich, wie die Firma Advanced Cell Technology erfährt. Bei Tests vollzog nur jeder sechste Klon eine Zellteilung. Ein Sechszeller war bereits ein Erfolg. Zur Gewinnung von Stammzellen bräuchte es aber einen Klon, der mindestens 100 Zellen umfasst. Das Klonen funktioniert also vornehmlich nach dem Zufallsprinzip und gleicht dem Stochern im Heuhaufen.

Doch solche Details kümmern Selbstdarsteller Raël nicht. Für ihn sind Stammzellen und Embryonen Wegwerfware, die dazu dienen, seine Wahnideen wie ein okkultes Zauberlehrling umzusetzen. Ausserdem

zahlen sich die Ankündigungen schon heute aus. Das Geschäft mit der Todesangst bringt dem esoterisch angehauchten Ufokult Millionen. Trauernde Eltern und alternde Krösusse zahlen Hunderttausende von Dollars. Die Sekte behauptet, schon bald eine Million Klonkunden zwecks Zellkonservierung in ihrer Kartei zu führen. Das neuste Kundensegment sieht die Raël-Klonfirma Clonaid bei den amerikanischen Soldaten. Wer von den Talibankämpfern abgeschossen wird, kann laut Raël schon bald im Sektenlabor zu neuem Leben erwachen.

Der Guru und seine Klonchefin Brigitte Boisselier machen zwar spektakuläre Ankündigungen, schweigen sich aber vornehm darüber aus, wie und wo sie die Klone erzeugen wollen. Trotzdem behaupten sie, bereits menschliche Embryonen geklont zu haben. Doch vieles deutet darauf hin, dass der Guru und seine Helfer in sektenhafter Selbstüberschätzung an sich selbst erfüllende Prophezeiungen glauben. Trotzdem muss man die Klonsekte ernst nehmen, denn die Erfahrungen mit Tieren zeigen, dass die technischen Hindernisse beim Klonen immer kleiner werden. Experimente könnten dereinst auch zweitklassigen Forschern gelingen.

Den Raëlisten ist aber vor allem zu misstrauen, weil das Klonen für sie eine religiöse oder ideologische Notwendigkeit ist. Sie glauben in ihrer Verblendung, dass wir Menschen das verunglückte Produkt von Genversuchen seien. Die ausserirdischen Wesen der Elohim hätten uns im Reagenzglas gezeugt und möchten uns nun bei der genetischen Veredelung helfen. Deshalb nehmen die Raëlisten beim Klonen eine göttliche Legitimation für sich in Anspruch. Um ethische oder moralische Fragen müssen sie sich also nicht kümmern. Sie behaupten denn auch, Jesus sei dank fortschrittlicher Klontechnik der Elohim aufgestanden.

Zweifel kennt Raël nicht. Wer den ehemaligen Autojournalisten für einen Klonvortrag engagieren will, muss satte 100 000 Dollar aufwerfen. Seine wissenschaftlichen Eingebungen will er von den Elohim erhalten. Man kann diese «Erkenntnisse» auch als spirituelle Einbildungen, Halluzinationen oder Wahnvorstellungen bezeichnen. So behauptet der Guru, er werde in den nächsten 20 Jahren Menschen als erwachsene Klone reproduzieren und ihnen das mühsame Heranwachsen ersparen. Er könne auch Gedächtnis und Persönlichkeit nahtlos in ihren neuen Körper transferieren. «Nach dem Tod wachen wir in einem neuen Körper auf wie nach einem nächtlichen Schlaf», erklärt der Guru. Das erlaube uns, ewig zu leben und das Wissen endlos zu kumulieren.

Das Paradies wird laut Raël schon bald wissenschaftliche Realität. Er träumt sogar von der Erzeugung künstlicher Intelligenz, die nicht mehr an einen Körper gebunden sein muss. «Das Leben in einem Computer wird möglich.» Dies glauben nicht nur ein paar einsame Spinner, sondern mehrere Zehntausend Anhänger in Dutzenden von Ländern. Und unter ihnen befinden sich viele Akademiker. Gebildete Leute also, die nicht mehr zwischen Realität und Sciencefiction unterscheiden können. Und auf verhängnisvolle Weise Religion mit Wissenschaft verwechseln.

because all promises were only vain lies and misconceptions - and because the clone being might be a monster in some way, because the cloning technique has not yet progressed to such an extent that it could be used without hesitation and without harm for the being to be cloned.

In this regard, look at the unbelievable, misinformative, truth-telling, profit- and follower-oriented inhumane and unbelievably primitive and mongrel and sectarian machinations of the cult cicerone of the Raël-movement, who calls himself leader of leaders and allegedly is in contact with Moses, Jesus and Buddha or something - if I remember correctly the stupid claims and fables in one of his books - sat at a table one morning on the planet of the Elohim and had breakfast with them, along with erotic pleasures there with wonderful and phantastically pretty female clones; and if you take a close look at the marvellous and the fantastic, then you will probably find exactly the hammer that, with these two words, exactly Nail on the head.

# Raël-Sekte: «Klon-Embryo verpflanzt»

*Der Arzt Severino Antinori behauptet, geklonte Embryonen verpflanzt zu haben. Nun doppelt die Raël-Sekte nach.*

Das makabere Rennen um das erste geklonte Baby geht in die nächste Runde. Monatelang hatte die Klonfirma Clonaid der Ufo-sekte Raël die Nase vorn. Brigitte Boisselier, Klonchefin des französischen Gurus Claude Vorilhon alias Raël, hatte in unzähligen nebulösen Ankündigungen Klonprojekte vorgestellt und das erste Klonbaby für das laufende Jahr versprochen. Vor zwei Wochen lief ihr jedoch der italienische Arzt Severino Antinori den Rang ab. Eine seiner Patientinnen sei in der

8. Woche mit einem Klon schwanger, berichtete die Zeitung «Gulf News». Der Arzt selber hüllte sich in Schweigen, wollte die Meldung aber auch nicht dementieren.

Nun waren die Raëlisten gefordert, die den Wettlauf um das erste Klonbaby unbedingt gewinnen wollen. Ihr Vorteil: Sie haben ein grosses Reservoir an gebärfähigen Anhängerinnen, die ihren Bauch gern für Klonexperimente zur Verfügung stellen, auch wenn sie mit vielen Missbildungen und Abtreibungen rechnen müssen. Wie nun die Agentur AFP meldete, hat die sekteneigene Klonfirma bereits mehrere Föten bis zu einem Stadium von mehr als hundert Zellen gezüchtet.

Sollte dies tatsächlich zutreffen, könnte es den Durchbruch beim Klonen von Menschen markieren. Klonspezialisten erklären nämlich, dass es zur Gewinnung von Stammzellen einen Klon von mindestens hundert Zellen brauche. Bei Tests hatte beispielsweise nur

jeder sechste Klon eine Zellteilung vollzogen. Das Züchten eines Achtzellers wird bereits als Erfolg gewertet.

## Schweigen über Erfolg

Details zum angeblichen Klonerfolg verriet Brigitte Boisselier nicht. Sie erklärte aber, die «gelungenen Embryonen» würden bereits in die Gebärmutter der am Experiment beteiligten Frauen eingesetzt. Die Klonchefin wollte nicht verraten, bei wie vielen Frauen der Eingriff schon vorgenommen worden ist. Auch über die Erfolgsquote der Schwangerschaften schweigt sie beharrlich. Immerhin verriet sie, dass sie zurzeit versuche, etwa ein Dutzend verstorbene oder todkranke Klienten «wiederzubeleben».

## Holographic crystal memories based on the Pleiari model

For some time now, earthly science has also been on the promising path of using crystals as a storage medium for electronic data - following the Pleiari model. The already known technique for the production of holographic images is used to describe crystals with the help of laser light technology. The specific property of crystals also makes it possible to store several holographic images next to each other in one and the same crystal. These new data storage systems (HDSS = Holographic Data Storage Systems) open up new dimensions in relation to known storage capacities: a cubic centimetre of crystal is said to be able to hold a data volume of one terabyte (TByte).

## Sighting Report


Observation at Karin Schmid Unterhaching:

Changed within one second fraction of original size, (like imploded, see drawing). From 20.25 o'clock to 20.27 o'clock still the way-movement could be observed by the telescope of Gerhard Hackner.
