

Review of facts no. 5

Now that it has been proven that the conifer tree actually existed in Fuchsbuel's stockpiles, the opportunity is good to present evidence for another " disappeared " tree, but this time without real projection.

On 17 October 1976 BEAM and 11 other people went to Langriemenholz near Hinwil (BEAM's home there) to launch an 85 m3 hot-air balloon which they had made the same day. The balloon was covered with aluminium foil because the intention was to arouse the interest of the air control and radar station of Dubendorf military airfield (another story). In fact, only minutes after the balloon had been launched, a military aircraft approached and flew over the group. In the process of building the balloon, BEAM had announced a special demonstration by Semjase, and at the balloon's launch site he told the people to watch the surroundings very closely. When the balloon departed quickly, BEAM followed it on his moped, having previously asked the others to follow it in their cars on a separate route. When they arrived at BEAM's home shortly afterwards, disappointed that they were not allowed to experience a sighting as expected, BEAM told them to return to the launch site immediately, where he told them that Semjase had eliminated a small tree in the short time of his absence. But when they examined the spot they could not find any sign that there had been a tree at the spot. The only clue that somehow supported BEAM's explanation was the fact that the tree standing alone in the meadow had grown on one side, i.e. on the side where BEAM had said the other tree had stood, the branch growth was greatly reduced. Later on, when the six photos that Guido Moosbrugger had taken returned from the laboratory, the proof was visible to everyone.

Review of facts No 6

An important aspect of the " Billy Meier case is the large amount of information about future events, scientific discoveries, catastrophes and the negative consequences of human behaviour, etc. BEAM has published an entire book on this subject under the title *Prophecies and Predictions*²⁶ . Since its publication in 1982 many more prophecies and predictions have been published, on the one hand by the " teenager" Eduard A. Meier, on the other hand by the prophets/KUnder Jeremiah and Enoch as well as the alien Hilak and Sfath. While the believing Christians, Jews, Muslims etc. do not see a problem in believing the prophecies of the old prophets or of " Jesus Christ" ²⁷, they vehemently reject the possibility that a man currently living in Switzerland is able to provide information about events etc. that will inevitably happen in the future (predictions), or will certainly happen, provided that with regard to the general behavior and thinking of mankind no change for the better occurs (prophecies). It is interesting and significant to note that, while the prophecies and prophecies offered in the Bible (Torah), the New Testament, or other 'holy books', are not necessarily true.

" Announcements" are NOT questioned and taken at face value, BEAM, despite its real 'Predictive ability', but with unfair intentions. In itself conclusive and logical thinking, as well as integrity, would require that the same standards of investigation and assessment be applied in the same or similar situations.

Before starting the study of the " prophecies and predictions part in the " Billy Meier case, it is important to address some basic conditions concerning the possibility of predictions. Since a prediction by definition must be 100% certain to come true, it requires that at least certain aspects of the future are already known when the prediction is made or elaborated. As we know from the " Pleiadic-Plejaric contact reports" *blocks*²⁸ , one of several variations to obtain information from the future consists in 'jumping' into the future by the application of technical means in order to observe the intended there. Examples of information obtained in this way are the following announcements: The total destruction of San Francisco, the tremendously strong seaquake lasting 5 minutes (9 points on the Richter scale)

off the coast of Portland in the USA, the "blowing up" of Auckland in New Zealand²⁹, the eruption of the Marsili underwater volcano in Italy, etc., all of which will happen in "the foreseeable future". (If you take these warnings seriously, you can act accordingly with foresight!)

However, the subject of this mysterious "simultaneity" of the dimensions past, present and future is not dealt with further in this text. But what we have to address: Is there any evidence that BEAM, or the extraterrestrials with whom he is in contact, are able to provide relevant information that was not known to the earthly scientists, or that they were not aware of when BEAM published it? Let us start with an example: Suppose that the author publishes two statements in a book this month (March 2020) (with ISBN = date of the first publication), predicting or claiming that 1. in 2031 on April 1 the International Space Station (ISS) will be hit by a meteorite, and 2. that in 2032 scientists will discover a hitherto unknown radiation emitted by the sun, which they will call "Strange Solar Wind". If it turns out that these two events happen exactly as predicted, how was this result evaluated, explained or judged? As a miracle? As two lucky strikes? As an extraordinary coincidence? As divine inspiration? As proof that it is indeed possible to predict the future? Proof that the future already exists? ...

What can already be concluded or predicted now is that the probability quotient that someone from the readership or the author himself is capable of predicting these two events exactly at the respective times exactly in the way mentioned is extremely low, practically at zero. (At present, clarifications are underway to calculate this likelihood ratio).

Now that we have studied and evaluated these two fictitious examples, the same evaluation standard should be applied fairly to the two following events. What would happen if exactly this improbability happened?

During the 31st contact talk³⁰, on 17 July 1975, BEAM talked with the alien Ptaah about our solar system:

Although BEAM wrote the name of this belt slightly differently in 1975 (as he had understood it phonetically in conversation), named Kaiber instead of Kuiper, there is no doubt that Ptaah spoke of the Kuiper belt³¹. The existence of the Kuiper belt was confirmed in 1980 by Julio Angel

Fernandez postulated and confirmed in 1988 by Scott Tremaine in a computer simulation. It was also Tremaine who coined the term "Kuiper-GOrtel".

What was most likely unknown to these two scientists: This GOrtel was already mentioned **five years earlier** in a contact report.

During the 150th contact on October 10, 1981, BEAM talked with the alien Quetzal Ober about many topics, as well as Ober's predictions. Below is an excerpt from the conversation:



Billy: ... Just say once, though, are already with this destroyer {Komet}: According to the prophecies transmitted to me, other comets and meteors of enormous size are haunting the earth and the life of this world. I am especially interested in the 'red meteor'. Is this the destroyer or is it another comet that always passes through our solar system?

Quetzal: Neither, my friend. The meteor mentioned in the prophecies, which will cause an enormous and very malicious destruction on earth, and which threatens to bring climatic, tectonic and other changes, will also split the earth's crust



from today's North Sea to the Black Sea, but this is not necessarily true, because certain factors are present today. It is coming from the depths of the world towards the SOL system and is, so to speak, an alien.

Billy: You mean that it is not a known comet that keeps on orbiting through our system?

Quetzal: That is correct, because this meteor flies on a path that leads it to the SOL system for the first time. It's never been in this space before.

Billy: And his ride shall be upon the earth end? Can't you do something about it?

Quetzal: You know very well that it will be like this and that we cannot stop this event. The cosmic forces themselves have pre-programmed this event, which could only be stopped or averted by the earth people themselves.



And during the 475th contact on 26 November 2008, this further information came from Ptaah:

Billy: ... Regarding the Red Meteor, which threatened the Earth on April 13, 2029, and which we already talked about on September 16, I was asked about some things and therefore I would like to know how big this guy actually is. To my knowledge the earthly astronomers have also discovered him already some time ago and call him Aprophis {Apophis} or something like that. In the year 2029 is supposed

he either hit the earth or barely missed it. If the latter should be the case then the next dangerous meteor appearance would be in the year 2036, whereby then an approach to the earth could even more lead to a catastrophe when the scientists do not do anything about it or change something with regard to the flight path of the meteor itself.

Ptaah: Its size is about 350 meters. What you say about the great danger the Red Meteor poses to the Earth is known to scientists. And if something does not result from a special influence of the outside SOL satellites, then the earth is indeed threatened with a catastrophe. In order to avoid this, however, the earthly scientists are also called upon to do everything possible to finally force the meteor out of its orbit.

This red meteor, now known as 99942 Apophis³², was discovered on 19 June 2004 by Roy A. Tucker, David J. Tholen and Fabrizio Bernardi at Kitt Peak National Observatory, almost **23 years after** it was first mentioned in contact reports.


Conclusion: As these just two of a large number of other and similar predicted information from BEAM's contact reports prove, BEAM published clear information about cosmic-astronomical facts years before they were officially discovered by earthly scientists. The logical question that had to be asked now: How is it possible that events that are not based on a cause caused by terrestrial human behaviour can be predicted with such precision? Since the probability that a single person can achieve two such perfect hits is practically zero, what would be the reasonable explanation? Since everything in the universe is based on the law of cause and effect, something like "a wish can be excluded. There is only one solution: Either BEAM is able to look directly into the future, or he receives information from people who are able to travel through space and who have the knowledge and scientific possibilities to carry out research, whose findings they then pass on to BEAM. This is in accordance with, and is proof of, what BEAM has been saying publicly since 1964, namely that it has contact with highly developed people from other stars (space-time structure/universe). In fact, there is no other reasonable and logical explanation, especially when all other conclusions resulting from the many logical questions posed above are taken into account.

Review of facts No 7

During the so called "Great Journey", when BEAM had the opportunity in 1975 to travel during five days through the vastness of the universe and even "across" to a "twin creation" (to DAL-"Universum"), he used the opportunity to take over 1000 photos of many different objects both in space and during the excursions on different worlds. He was also allowed to take some photos of Asket and Nera, which, however, appeared a bit foggy and blurred due to the different radiation in the spaceship. The fact that BEAM's opponents in the USA found two doppelgangers (which by the way had been mentioned in a contact report before), the singers/dancers Michelle DellaFave and Susan Lund (from the "Dean Martin" show), led to the accusatory claim that BEAM had taken the photos of Asket and Nera from a TV set.

Top left: Michelle DellaFave, Susan Lund and another singer; top right and left bottom: 2 photos based on BEAM's originals. Even though the exact manipulations cannot be determined: There are obvious differences to the photos from the show (see markings), which suggests that they were not taken from a TV set.

BEAM attributed the fact that Asket's hair colour appears light blond instead of brownish as in reality to the radiation in the spaceship. When he was later confronted with the pictures of the doppelgangers, BEAM stopped the sale of the three existing photos. Later, however, Ptaah confirmed that BEAM's photos really showed Asket, but that some manipulations by "foreign forces" had been made on the pictures, etc.

Review of facts No 8

A particularly important learning effect from the study of the spiritual teachings, i.e. the teachings of creation energy, is the realization of man's duty to bear responsibility at all times: towards himself, towards his fellow men and towards nature with its fauna and flora. As a result, BEAM, in the framework of its " Mission", has since childhood sent out various prophetic and predictive warnings to governments, the media and certain scientists etc., in order to induce them to immediately take the necessary measures to slow down and stop the population growth, so that the otherwise inevitable bad effects can be prevented. The result of his various attempts to awaken a corresponding perception of responsibility in the individuals and organisations contacted was devastating: no reaction!

Unlimited growth in limited space leads to destruction and death!

This truism has apparently not penetrated the consciousness of the majority of those who, as the highest leaders in governments, business and religion or as part of the so-called 'leading media', are or would be responsible for fulfilling their duty to inform for the benefit of the people, the citizens, consumers and the coming generations. Practically all of them have failed and are still failing in the face of legal action and refuse to accept the facts and initiate the necessary measures. The reality and fact is that **the more** people live on a restricted area - a building, land, country, continent or planetary landmass,

- **the** more consumption of grain, meat, vegetables, drinking water, clothing, electricity, oil, coal, gas, wood, charcoal, ores, rare earths, air miles, etc.
- **the** more manufacture/production of vehicles (of which well over 95% are powered by fossil fuels), roads, buildings, manure, toxic substances of all kinds, waste (radioactive, plastic, food, etc.), sewage, charcoal, methane, CO₂, nitrous oxide and other gases, household and disposable items, etc.
- **the** more extraction/exploitation/extinction/emptying etc. of rainforests, intact nature, groundwater, ores, animal and plant species, etc.
- **the** greater and more frequent the social and personal effects, such as aggression, migration, poverty stress, warmongering, extremism, religious and ideological fundamentalism, false selfishness, relentlessness, crime, pandemics, terrorism, men's instability, psychological disorders, cancer, allergies, fatalism, violence against women and children, indifference towards fellow men and nature, etc.

This leads to the conclusion that global warming³⁵ is only a symptom, like fever in the case of an untreated infection caused by an open fracture. The necessary measures are considered in relation to the above example: What would be the sensible and necessary medical treatment in this case?

- 1) Surgery, wound care, bone stabilisation, medication (antibiotics/painkillers, ...), physiotherapy, self-training, etc.,
or
- 2) Cover the wound so that the sight of it does not frighten you, then administer painkillers in ever higher doses, etc., and then hope that everything heals by itself?

If we compare the way in which politics, business, religions, the media and particularly certain population groups in the West deal with major global problems, this corresponds to the following approach (symptom versus cause):

- 1) Focus on reducing the increased emissions of CO₂ and methane, etc., demand for a vegan lifestyle for all, intellectual tabooing of the term 'overpopulation', symbolic proclamation of a climate emergency, call for panic and civil disobedience, etc. *instead of*

- 2) Recognition that the overpopulation - the unchecked population growth of globally about 100 million people net more per year (!)³⁶ - is the root cause and the intensifier for ALL other problems, and that causally effective measures must be initiated without delay!

That everything is only a distribution problem, as is claimed in "Fridays for Future" circles (see also these two articles by the author 37 38)³⁵ half-baked wishful thinking and a nasty claim. It is enough to imagine the transport system and the local economic-social effects in a plastic, practical and concrete way.

Yet the principle is or was so easy to understand:

If a cake has to be divided among 10 people, the pieces are larger than with 20 people. In order to keep the pieces the same size for more and more eaters, more and more cakes have to be baked, which constantly increases the consumption of resources, such as sugar (agriculture/tropics), cream (farms), eggs (industrial "egg factories"), chocolate (and others).chocolate (e.g. tropics), baking heat (electricity, wood, coal, gas), oven (metal = ore mining / blast furnace), cake utensils (e.g. plastic = oil), recipe (e.g. smart phone/tablet = rare earths = mining), etc. etc.

Finally, **a few more questions**, the answers to which will necessarily be hard and uncomfortable, but which alone will lead to the desired results, provided that there is an honest and deep-seated interest in mitigating the increasingly threatening events in nature and society and, who knows, to change the polarity of the situation in the future:

- 1) What is the logical measure to take if something unhealthy, harmful or life-threatening results from unchecked growth?

Answer: Prevent further growth and immediately initiate effective measures for reduction.

- 2) If this logical approach is applied to the problem of overpopulation (as he suspects, there are about 100 **million** more consumers every year), which measures should be taken immediately?

Answer: There is only one humane measure, namely the avoidance or reduction of pregnancies (birth control and pregnancy prevention including birth stops, etc.).

- 3) Since this logical measure is linked to the human reproductive instinct and self-referential After the Flood, what can be done to resolve this conflict?

Answer: Through continuous educational work and information from all governments and responsible persons and organizations worldwide, etc., it is possible to show the people the seriousness of the situation of the planet realistically, but without panic-mongering, and to explain to them the urgent necessity of a worldwide birth regulation with the aim of one, no or maximum two child family planning. emotional and uplifting hysteria as well as due to intellectual and childish short-circuit susceptibility, etc. and - realistically seen - immature, even "handicapped".

And so mankind is moving spirally and Titanic-like steadily further down the abyss, and the hot potato is passed on from hand to hand unseen all around, the proverbial elephant in the glass house is still ignored, and it is still cowardly avoided to finally put the comprehensive and life-threatening taboo, **the catastrophe of the upper classes**, into the limelight so that logical, effective and purposeful thinking and acting is made possible for a long time.

Thus they, like unfortunately 99.999999 percent of the earthly humanity, are poking around in the fog of faith and/or ideology, instead of perceiving the clearing through unbiased thinking and then stepping out into the bright landscape to recognize the shining lighthouse that shows them the way to a life in recognition of the effective truth and reality.

This in turn leads to some questions:

1. How does the author arrive at this very positive assessment or evaluation of BEAM's oeuvre, which could be assessed as euphoric, arrogant and presumptuous, at least by people not yet familiar with the subject matter?

Answer: Whoever is willing to read BEAM's books with an open and unbiased attitude cannot avoid sharing the author's conclusion. What the books

What makes BEAM unique is that its content can be comprehensively evaluated and compared with one's own thought processes and interactions with fellow human beings and nature in general. Everything is logical in itself, and there are no contradictions within the various passages and realities. Answer: On the one hand, since the age of seven, BEAM was intensively taught by an alien named Sfath, and later by ascetic, and was enabled to experience events in the future as well as in the past and to process all kinds of situations and observations. On the other hand, he has conscious access to knowledge and information that former personalities could collect and store, which were animated by the same spirit form that animates BEAM today. 3. How does BEAM actually write his books? Does he copy texts of old philosophers or quotes from encyclopedias?

Answer: While BEAM occasionally quotes Wikipedia or encyclopedias in his contact reports or periodicals, e.g. to point out differences between 'official' and his own definitions, information and teachings etc., he hardly ever does so in his spiritual teaching-based books. Nevertheless, all his books are original works and therefore do not need a bibliography etc. If other authors have written about the same topics before BEAM, such as " The Power of Thought", or in BEAM's case his book " The Power of Thought", then it is not plagiarism at all, because the information and explanations in BEAM's books are 100% in accordance with reality and do not contain any speculations, because they are in accordance with reality. And as far as the " power of thought" is concerned, i.e. the fact that people shape their lives by using, controlling or not controlling their thoughts, is something that everybody can study and prove for himself, among other things by the placebo and nocebo effect.

As for the way BEAM writes his books: "For those who have had or have had the opportunity to observe the whole process, the results are astonishing. According to his comment - "*I don't have time to spend any more on the most important things for writing*" - the process is as follows: BEAM defines the subject, sits down at the computer and starts to type, i.e. to write. During the writing process, BEAM often sends copies of what he has just written to three proofreaders, who then send the corrected sheets44 back to him. It is impressive to see that BEAM writes his books in one go, where no additional rewriting or editing is necessary: start, write, finished!

Consequently, the task of proofreaders is more or less limited to correcting spelling mistakes.

Afterword

Now that enough food for thought has been provided for readers to draw their own conclusions, it is time to finish this essay. What would fit better than to quote the man himself, who is at the centre of this unique story; the man who stands firm and unshakable in the midst of worldly turmoil and who stands unaffected by the many false and slanderous hostilities by ignorant adversaries and believers, because he knows that the real and factual problem is not with him (to find readers and study), but with them (to find access to truth and reality).

Corona crisis and the EU

The current crisis makes us aware that in an emergency, each state looks to itself first. No help is to be expected from high courts, distant officials and international institutions. International law loses its practical significance, at least temporarily. Nevertheless, the call for more centralisation is already being heard in the EU. The rhetoric will be that EU structures need to be strengthened. And in Switzerland too, after the storm, the framework agreement and the institutional connection to the EU will quickly become an issue again. The internationalists and EU accession supporters will try to reinterpret the Corona crisis in their favour and present the accession to the EU as having no alternative.

Borders are closed. Mobility will be restricted. Medical goods are being held back. The Corona crisis shows that in a state of emergency, every country and every government looks to itself first. International law is effectively suspended. No help is to be expected from high courts, distant officials and international administrations. In contrast, this is already being reinterpreted and more centralisation is being demanded in Brussels. The rhetoric is familiar to us: Too little coordination, a patchwork quilt, unilateral decisions, nationalism. The EU is giving a bad image, he said. And the bottom line is then usually in crises: More centralism, more powers for technocrats and remote civil servants. The great advantages of decentralised structures are completely ignored. Europe's heritage would be precisely diversity, not uniformity. The competition of ideas and systems has made us strong and successful. We should think about that when this crisis is over.

However, it can also be assumed in Switzerland that after the Corona state of emergency the voices of an EU connection will once again be heard. The business associations and EU accession supporters will reinterpret Corona in their favour and emphasise that there is now a need for more solidarity, coordination and cooperation. The EU framework agreement will be the only solution without alternative, say the EU supporters. Without integration into the EU structures we would stand alone and not be prepared for future crises, they will claim. Yet the opposite is true. The decentralised structures make us resistant. Our unbureaucratic and self-reliant culture best protects us from collapse. Flexibility and pragmatism are the keywords that we can only keep unbound and independent. This means that there must be no political and institutional ties to the EU. Cooperation and exchange are also possible without this. And as Corona shows, these institutions are of no use in an emergency. In the end, what counts is global competitiveness and the people on the ground.

No gatherings of more than two people: Federal and state governments agree on a ban on contact

The federal and state governments want to introduce a kind of ban on contact in the fight against the spread of the coronavirus. Chancellor Angela Merkel and the State Premiers agreed during a telephone conference on Sunday, according to information from the German Press Agency, to ban in principle any gathering of more than two people.

Families and persons living in the same household will be excluded. The ban is to apply for at least two weeks.

Laschet and Söder fight over the telephone

According to media reports, a dispute arose between Bavarian Prime Minister Markus Söder (CSU) and his counterpart from North Rhine-Westphalia, Armin Laschet (CDU), during the Minister-Presidents' telephone conference on the Corona crisis on Saturday afternoon. As "FOCUS Online" learned, Laschet and eleven colleagues had advocated not to make the stay in the flat the decisive criterion for the cuts for the population ("concept curfew"), but to make the number of contacts in public space ("concept contact ban").

Laschet had also massively attacked Söder, because he had already ordered his own measures with initial restrictions for Bavaria on Friday "without consultation" with the federal government and the other states. Söder had "made it clear" that he would not accept the paper of the twelve state premiers. "This can be seen as a threat to leave the gear shift", it was said.

After the Robert Koch Institute announced that there is a shortage of places to ventilate corona patients and that there is still not enough protective equipment for doctors in Germany, the head of the German Police Union (DPoIG), Rainer Wendt, has severely criticised the German government.

"Germany was not prepared for the Corona epidemic," Wendt told "Bild". And further: "There were and are neither enough protective suits, nor enough protective masks or rubber gloves, and that is only the tip of the iceberg."

The "complete failure" of the Federal Government is particularly evident in the lack of tests for COVID-19 infections. "This gross negligence endangers human lives."

Negligence against better knowledge

To this day, nothing has changed. The trade unionist is therefore calling for a national epidemic reserve: "Germany must at all times provide protective equipment, respiratory technology and other

...to provide essential supplies in case of an outbreak." Domestic production of these essential items must be ramped up and sales abroad must be strictly quota-based. The police expert also accused the government of acting negligently against its better judgment. Even from its own epidemic planning games LÜKEX in 2007, the government has apparently learned nothing", Wendt told the newspaper "Bild". Even then, the threat of failure by the authorities in the event of a crisis, the inadequate stockpiling of protective equipment and other everyday necessities had already become apparent. "Everything that now aggravates the crisis was predictable. "If no lessons are learned, the Corona crisis could lead to disaster."

The head of the DPoIG nevertheless demands a stronger role for the federal government in the event of an epidemic. "What we need now is a centrally controlled procedure: In such a situation, the federal government must be authorized to give instructions to the states. It is not acceptable, for example, that Bavaria closes playgrounds and imposes strict restrictions on going out, and that in Berlin the masses continue to barbecue in the park. (dts)

Normal Americans can no longer numb themselves with sport and gluttony. Instead, they can clearly see the vicious and cowardly ruling class that exploits and despises them. If only they would open their eyes to reality.

Anyone with eyes to see can clearly see that the United States of America is a confused empire in steep decline, firmly rooted in its staging of "Bread and Games". The reason this debate has gone far beyond the rational time for action is that our education system is not a system of learning, but rather a glorified kindergarten and food delivery service.

Proletarian parents are no longer able to stay at home and raise their children because it now takes two parents, who usually have several jobs, to earn less than a working parent did forty years ago.

In the entire Los Angeles school district, 70 percent of all students are below the poverty line and depend on the school system for the majority of their meals. In the richest country in the world, this is an absolute disgrace. The virus of structural economic inequality is a much more long-term and deadly problem than the corona virus, and the ruling class and its shameless lackeys in the press have no interest in ever honestly addressing or acknowledging it.

The corporate whores in Congress and the White House (of both parties) also cheerfully inform Americans that universal health care for single people, which every other industrialized nation in the world already has, is a pipe dream and an impossibility.

They tell us they could never pay for something as decadent and luxurious as health care. But then they magically pull \$1.5 trillion out of their gold-plated butts to avert a self-inflicted collapse. It's amazing how the lords of finance can miraculously make money appear to get things done when their exorbitant wealth is at stake and not the health and well-being of ordinary Americans.

Anti-Russian opinion-forming by the European Union in times of the Corona pandemic

While the world is fighting against COVID-19, a real pandemic, the European Union seems to be concerned about a fake virus about the all-powerful, omnipresent and all-encompassing "Russian disinformation". To the detriment of all concerned.

News of a brand new EU report, still classified but leaked to Reuters and the Daily Mail, has made over a hundred headlines across Europe in recent days.

The report is said to have been prepared by the European External Action Service (EEAS). And although the EEAS - probably following guidelines on social distancing - did not feel like providing RT with the paper, anecdotal evidence suggests that our station is an integral part of the report itself. At least no major media coverage of the report resisted the urge to write about RT. This is what they dug up:

The Daily Express accused the Russian media of murderous conspiracies and opposed important factual reports on the social behaviour of people during a pandemic:

Russia plans to increase the number of corona virus death victims in Europe with fake messages. A recent report by Kremlin-backed Russia Today showed Britons ignoring the closure and visiting the Spanish seaside resort of Benidorm.

The Financial Times saw the real threat in the "advancing apocalypse" of RT's popularity:

RT Spanish - a branch of the state-sponsored Russian news agency formerly known as Russia Today - posted more than 6.8 million shared articles on Facebook, Twitter and Reddit about corona virus content between January 1 and March 12, according to the analysis. This made it the twelfth most popular source among the domains studied, ahead of several major Western media companies.

Reuters, the most reticent agency in the group, played the sound cop:

Russia is also clearly stepping up its own efforts to shape the international narrative. The most widely read news in Russia Today this weekend was the drastic reduction in the upcoming US-led NATO exercise 'Defender 2020' in Europe and the mockery of the United States for not being willing to risk infection to demonstrate its commitment to the continent.

The Independent affirmed the paranoia of the establishment and wrote

The EU accuses Russia of trying to destabilise the West with a corona virus disinformation campaign.

The EU analysis suggests that Kremlin-funded media like RT deliberately

...apocalyptic stories. It cites 'fake news' created by Russia in Italy, the western epicentre of the crisis, which reported that health systems elsewhere were unable to cope - and that people were left to die. I'll get to Italy in a minute. But keep in mind that the report of the "Independent" appeared only four days after the report of the British newspaper The Guardian with the following headline:

The Corona virus could force British doctors to decide who they want to save. A lack of resources could mean that younger, healthier patients are given priority while others die.

This cognitive dissonance is causing me to hallucinate.

In summary, the mass media have published hundreds of articles on the threat of Russian disinformation, highlighting RT without providing a single example of a "false report", error, inaccuracy or ~~said~~ "disinformation". No evidence was offered to link RT in any article to such activities - because there is none. Now tell me who is really spreading disinformation here.

There are of course cases of misinformation, disinformation and old-fashioned misreporting of the corona virus pandemic. The US magazine Foreign Policy, for example, exposed three such stories in January - all from US and Canadian media.

Unfortunately, this phenomenon is not untypical in the face of a new, rapidly growing, barely understood threat, and does not make any part of the world or any country's media immune.

So why RT and why Russia? Russia has not created memes on hand disinfectants, although we now share them with as much pleasure as our US and German colleagues, while we stock up on buckwheat. Russia has not invented the United Kingdom's proposals on herd immunity, nor reports on Italian hospitals. The latter are so anxious for resources that they have to prioritise patients according to age and treatment options.

What we can see from the EEAS paper, the leaks and the subsequent headlines in the press is their common core premise that Russia is deliberately engaged in a short-lived "disinformation campaign" to make Europe look bad, undermine public confidence and bring the "European project" to its final collapse.

Let us leave aside the absurd paranoia under which the poor "spirit" must suffer to sense this evil Russian master plan. Let us consider this: If the above stories, however damaging to the European image, are based on reality, how can Russia be at fault? By portraying responsible, factual reporting and every undue knee-jerk reaction to Brussels as a foreign disinformation campaign, the EEAS and the mainstream media pretend that their biggest problem is PR, not the pandemic.

To understand the cause of this rather disturbing dissonance, it is important to understand who or what is behind this arsonist report. The EEAS, the East Stratcom Task Force which again produced the dubious EUvsDisinfo, clearly relied on the work of these departments. As the Daily Mail put it:

The information analysed by the Daily Mail was compiled by EUvsDisinfo, a project of the European External Action Service (EEAS), funded by the European Union. In their own words: EUvsDisinfo is the flagship project of the East StratCom Task Force of the European External Action Service.

EUvsDisinfo started with the declared aim to pursue, fight and correct disinformation. You guessed it: by definition these were any fact or opinion that undermined the core EU issues. In their view, any deviation from the thesis that "it's always sunny in Brussels" poses an existential threat to the EU project. Especially if this deviation comes from Russia.

The reputation of the organization suffered a severe blow a few years ago when it was called "fake news" by independent Dutch media when it published three different reports about Ukraine. The reports were impeccably factual and objective and dealt with issues of corruption, LGBTQ rights and right-wing extremism in Ukraine. According to EUvsDisinfo, any admission of such problems in an EU candidate country is tantamount to disinformation by the Kremlin, and the reports were carelessly labelled "fake news".

The Dutch media, with the support of their government, filed a complaint - and won. Since then, EUvsDisinfo has recalibrated itself to pursue only "Russian disinformation". By following how

obsessively follows mostly domestic Russian talk shows and looks meticulously at their news distribution lists when someone is not respectful enough of the EU.

EUvsDisinfo is a purely political thought police, disguised as an impartial observer, without any claim to balance or even common sense. In their view, all EU problems are simultaneously the result of Kremlin disinformation and are Kremlin disinformation in themselves. The rigour of their analysis is like a trip to L.A.'s Chinatown, where two men with corona virus are found, one of whom dies. Then it is explained that COVID-19 only affects Asian men on the west coast of the USA and has a mortality rate of 50 percent. Nearsighted, partially blind, largely ignorant.

Last funny fact: RT contributions, however dubious, only make up a ridiculous two percent of the total number in the extensive EUvsDisInfo database. Nevertheless, the Project Group's talking heads and press releases never fail to mention our channel in its raison d'être as a major threat to civilisation when they are lobbying for the next round of funding. These guys know how to do good PR.

Whatever the forecasts, the corona virus pandemic is already too real a challenge for the world to have time to chase a phantom. And for the first time in a long time, from South Korea to Russia, Italy and the US, we are laughing together over toilet paper memes, crying over sick relatives and worrying about short-term social isolation and long-term economic consequences. This is the time when we commit ourselves to truly global understanding, cooperation and support. The EEAS's interim efforts to sow discord between peoples and nations are not only shameful but also dangerous.

Not so because of the risk of corona virus disease, but because of the drastic consequences of the containment measures, i.e. large-scale quarantine and shutdown of the entire economy. 1.7 billion people in more than 50 countries were ordered to stay at home to prevent the spread of the infection, the first time in world history.

What we are witnessing is an unprecedented restriction of civil liberties, and we must be concerned about this. The anti-democrats are using the crisis to implement their authoritarian agenda without resistance. Unfortunately, many people are prepared to give up their freedoms for the sake of a semblance of security. Those who are behind the media scaremongering know this.

A clear indicator of the mood in the economy is the dramatic fall in stock market prices. On Monday the Dow fell again by over 3 percent and stands at 18,591 points. Despite the announcement of gigantic bailouts in the trillions of dollars by the US Treasury and the Federal Reserve, in other words thousands of billions, the markets have no confidence, and the flood of money will save the economy from great damage.

Now it's not just about the banking sector as in 2008, the too-big-to-fail that was rescued, but about almost all industries, and that worldwide.

Let's assume that the spread of the coronavirus will be halted in a few months and the emergency and curfew will be relaxed, the companies will start working again, ... it will take a long time, perhaps years, before the situation returns to normal and we are back to pre-crisis levels. But we will never be there again, because all the bubbles will burst and the illusory prosperity will disappear. Yes, illusory prosperity that was not created, but was made possible by the money press and an orgy of debt for 30 years.

The debt of states, municipalities, corporations, businesses and private households has never been as high as it is today. This debt economy, with money that costs nothing because it is forgiven with the lowest interest rates, has caused an increase in GDP, but in real terms there has been no increase at all. There has been no increase in productivity. The mistakes have been whitewashed with money, only now the façade will not crumble, it will burst away.

It is ironic how the tiny virus has punctured the huge speculation bubbles and let the air escape. That the markets, which are completely bloated with cheap money or free money, will collapse before the end of this year, was clear to me and other colleagues, something we could not have foreseen, a virus will be the trigger of the avalanche that will rush into the valley and sweep everything away.

If the standstill in the most important industrialized countries continues for months, if nothing is produced and sold, and if there is no income, then there will be a wave of bankruptcies and associated unemployment that we cannot even imagine. All industries will be in ruins after state aid, but the state cannot save them all, only the so-called "key industries".

On March 13, Olaf Scholz, Vice Chancellor, Minister of Finance and Bilderberger promised in Maybrit Illner's broadcast that companies will receive generous support from the state. The "billion-dollar reserves" which the state has been able to collect thanks to a good economy are to be used to support the economy. "We have enough money, we can help everyone and we will do so," Scholz promised.

What this dwarf said is a complete lie, because the German state has no "billion-dollar reserves", because there is no account with a credit balance, there was also no good economy from which to make a deposit. What Scholz is lying about is once again just a tranquilizing pill for the naïve TV consumers, who believe everything the media and politicians tell them.

The German state, like everyone else, is up to its ears in debt. A state has only two sources of money, tax revenue and credit. But if the economy is at a standstill because of curfews, if there is no turnover and no wages are paid, then there are no taxes to collect. All that remains is credit as a source of money, which means even more debt.

What Scholz means by "reserves" is not what we normal people understand by it, i.e. a credit balance, but for him it is the possibility to use the credit limit of the FRG even more, i.e. to go even more into the red. But he won't give this money away, but will give it to the companies in exchange for a share. In other words, in the end there will be a nationalization of most companies, just like Commerzbank. In the end, most of the companies belong to Olaf Scholz, and we have the second Socialist Republic on German soil, the GDR 2.0!!! Could also be the third one, because the Nazi regime was also so-cialist, characterized by planned economy and state-owned enterprises.

What I mean to say is that this economic crisis, which the virus did not cause but triggered, can lead to socialism. The call for the state can already be heard. Even more state control than rescue in times of need. Only, history shows that socialism promised paradise but delivered hell. Since it's a bad product, the "marketing" of the agitators is all the better.

Hey, choose us, we'll beg and mother you, take away all your worries and give you everything you want. You want the total provider state, you got it.

What I will mention as another source is robbery, the state can expropriate and plunder. It will do so when the other two sources of funding are underperforming. Then the credit balances in the banks are accessed, the safe-deposit boxes are opened, forced mortgages on real estate are imposed or quite simply, whatever is of value is confiscated and expropriated. It all happened in the past. If there is one thing the rulers are very good at, it is passing laws that legalise their raid on the wealthy part of the population. This is called "equalization of burdens" after the war or "solidarity surcharge" since 1991. The 5.5 percent "supplementary levy" to income tax and corporate income tax was only supposed to be valid for one year, but is still valid today.

Does it bother anyone that the German state has been carrying out this theft from the working population against all promises for almost 30 years? No, the Germans like paying taxes. This stupidity is only surpassed by the Scandinavians. Although the neighboring countries are no better.

Socialism can only redistribute, take something from one group and give it to other groups. That's the way it is in Germany anyway, because only 16 million people create added value and pay into the pot, which brings out 66 million. The completely shameful thing about it is that this middle class, which bears the whole burden from which the majority profits, is also constantly being insulted and bullied, not praised.

So we have to worry, this crisis is being used to restrict our freedoms even further and to further reduce democracy and the right to a say. There is no way that these failures and the whistles that have brought us this chaos can lead us out of the crisis unscathed, because they use the same means, more money, more debt, more gangsterism and more state.

The right recipe is less state, more freedom and more personal responsibility. The claim that the free market economy has failed is a lie, because it does not exist. What we have so far is a covert planned economy, with the central banks playing the biggest role. You mean with...

They could control the money supply and interest rate policy, they could generate demand or trigger innovations.

What they actually do with it is to keep non-viable systems artificially alive instead of letting what is not successful die. When the banks went bankrupt in 2008, they should have been let go. The land consolidation, the reading of good and bad, did not take place. They were taken away from the risk of dying, so they did even riskier business and so even bigger bubbles were created.

This "liberation" from any risk and the negative consequences of mismanagement, which, no longer having to learn from mistakes, feeling no pain when you do something wrong, has been transferred from the banks to the economy, and even to society as a whole. There is no longer natural selection, but rather the weak are supported, who cannot be expected to make any hardship or sacrifice.

Let me say it clearly, it is done as if Dying was something unusual, but it is part of life, part of nature, and we all die sooner or later. Birth is the beginning and death the end of the short earthly existence. But death must no longer exist, it is concealed, hidden, is not visible, so that what should have died long ago is supported and subsidised.

What has happened as a result is the creation of more and more entities that burden the system instead of strengthening it. So what has been happening in the West over the last 30 years... A society has been bred of sissies, hot showers and mimosas who can't take any kind of pressure and immediately cry out for help like a baby. The state is happy to help, because that way everybody becomes dependent on it.

The best example is currently taking place of how most people in the countries affected by the coronavirus have no self-confidence, no self-responsibility, are not prepared, but instead push their panties, sit frozen in front of the screens and watch the propaganda. Above all, you have to stack toilet paper at home. Totally disturbed!

Listen people, President Roosevelt got it right in his inaugural address in 1933 after the stock market crash, the Great Depression and the Great Depression:

"So let me first express my conviction that there is only one thing we have to fear, fear itself - nameless, unreasonable, unfounded terror that paralyses necessary efforts to turn regression into progress. In every dark hour of our national life, a leadership of frankness and energy is met with the understanding and support of the people themselves, which is essential for victory.

No Corona emergency plan for the homeless: Is Germany threatened by a humanitarian catastrophe?

Corona pandemic: everywhere, makeshift help for homeless people collapses like a cart house. Municipalities and federal states are obviously overstretched, and the federal government has no plan. When Chancellor Angela Merkel (CDU) announced strict exit restrictions for all German residents on Sunday to prevent the unchecked spread of the corona virus, she constantly spoke of a "we". Out of consideration for ourselves and other people, we should keep our distance, not go out on the streets in groups and stay at home whenever possible. In doing so, she was perhaps actually worried about the elderly and chronically ill. Probably, the reduced health care system, which is threatened by total overload, caused her real headaches for the first time. Only one group had forgotten her once again when she spoke: The hundreds of thousands of homeless people in Germany who cannot "stay at home" because they have no home at all.

BAGW: Supply of homeless people collapses

The situation of the homeless is becoming increasingly dramatic. In many places, offers of help break down completely. The "blackboards" and showers are closing, even the emergency supply is partially stopped. On Friday, the Federal Working Group for Assistance to the Homeless (BAGW) therefore sounded the alarm. They were "very concerned about the employees and clients". Thus, there is a great deal of helplessness in the aid facilities. Politicians and administrations are doing far too little to adequately protect homeless people.

In addition to a lack of information, there is also a lack of protective clothing and disinfectants. Both could no longer be procured at present. "Therefore, it is absolutely impossible for many institutions and services that the entire area of homeless assistance, especially the stationary facilities and emergency sleeping places, day meetings and care services are not assigned to the system-relevant areas," criticized the BAGW. It fears that "the crisis will continue for weeks to come and that the financial and care situation of those living on the street will deteriorate further". Even now, many would no longer be able to receive the daily rates of social welfare payments to which they were entitled, as job centres have closed. Therefore mobile care services are urgently needed, according to the BAGW.

Humanitarian disaster in Hamburg

In Hamburg, where an estimated 2000 people - probably more - are living on the streets without any accommodation, the managing director of the street magazine Hinz&Kunz, Jörn Sturm, warned last week

a humanitarian disaster. At present, "the supply of food, money and medical services to the homeless is not guaranteed", he told the newspaper "Hamburger Morgenpost". The reason: the network for helping the poorest is largely held together by volunteers. But even these often belong to a particularly vulnerable risk group themselves. Sturm demands a "professional corona coordination office".

According to the Hamburg Senate, the city already uses two emergency shelters with 650 places as isolation locations. In one shelter, the state government has already ordered quarantine because of a sick person. For days now, about 300 affected persons have not been allowed to leave the facility, and other persons in need have no access. An inquiry by the author last Friday about the grievances and possible plans to remedy them has not yet been answered by the Hamburg Senate.

Berlin homeless aid threatens "Shutdown"

In Berlin, an estimated 10,000 people live on the streets without shelter, and tens of thousands more are registered in emergency shelters. According to an inquiry by the BAGW to aid organizations in the capital, facilities are largely closed and have shifted the supply of food, if it was maintained at all, to the streets. The "Tafeln" gradually ceased operations, and their presence in emergency overnight stays and semi-stationary facilities was no longer guaranteed. "If cases of infection become known, there is a threat of shutdown", the BAGW commented on the reports from Berlin.

The Berlin Senate Department for Integration, Labour and Social Affairs (SenIAS) is "aware of the problem", the spokesman for the authorities, Stefan Strauss, assured last week upon request. Together with independent institutions and the refrigeration assistance, they are "intensively" looking for solutions to accommodate and care for those affected. Buildings suitable for quarantine and health consultations are needed. However, the speaker did not specify which measures are already being implemented and in what form.

Last Thursday Berlin's Social Senator Elke Breitenbach (Die Linke) reaffirmed her good will: "We need a rescue parachute for homeless people as well", she told the news agency dpa. Her proposals range from an expansion of emergency shelters to all-day accommodation to the employment of full-time social workers for addicts.

Federal government shifts responsibility to municipalities

The Federal Ministry of Labour and Social Affairs (BMAS) has no concrete plans at all to avert this looming humanitarian catastrophe. BMAS spokeswoman Maja Winter told the author that her agency had only - albeit independently of the Corona pandemic - increased the annual support of the Federal Working Group for the Assistance of the Homeless (BAGW) by 100,000 to 497,000 euros. The support is used, among other things, for the "further development of assistance approaches and advice", she said. And: "In general, the accommodation and care of the homeless is the responsibility of the states and municipalities", she said, and this also applies to the financial means required for this purpose.

Furthermore, the BMAS immediately referred the matter to the Federal Ministry of Health (BMG). The BMG is responsible for the medical protection and health situation of (also) homeless people. However, BMG spokesman Sebastian Gülde was also unable to provide concrete plans. The protection of "vulnerable groups", such as homeless people and their caring staff, is at the forefront of pandemic planning, he explained. This includes the ordering of domestic quarantine by the health authorities. The health authorities must also check that people who are ill in emergency shelters and community facilities are separated from healthy people and that special infection hygiene measures are observed. The Robert Koch Institute would provide information on recommended measures, Gülde said.

In the RKI's "pandemic planning", however, this risk group of homeless people does not appear at all. Nor did the BMG spokesman explain how and with what means the federal states and municipalities are to master the social problems in Germany. According to the BAGW survey, these problems are serious not only in Berlin and Hamburg. Even more: The Corona pandemic is becoming a question of existence for the poorest of the poor.

Fake blossoms of the corona crisis: a smile for the "systemically relevant"

In the crisis it becomes clear who keeps the country going: Low-paid workers like nurses and shop assistants. This has also been noticed by politicians, who are now thanking these systemically

important people and calling on everyone to support them - with a smile, for example.

The current corona crisis has revealed one thing, at least in Germany: Those that are indispensable for the functioning of the community, which are the "system relevant" ones, especially in a situation like the present one, are at the lower end of the wage scale with their salary. They are health care workers and nurses, salesmen and truck drivers, not managers, politicians, artists and other stars and starlets of any gender.

Apparently, German politicians have also recognized this. At least some statements seem to point to it. For example, in her TV address on Wednesday, which was highly praised by the mainstream media, Chancellor Angela Merkel thanked all those working in the health sector:

What you do is tremendous, and I thank you for it with all my heart.

The retail trade employees also received a warm handshake from the German government:

And let me also express my thanks here to people who are thanked too rarely. Anyone who sits at a supermarket checkout these days or fills shelves is doing one of the hardest jobs there is at the moment. Thank you for being there for your fellow citizens and literally keeping the place running.

The ambitious Minister of Health Jens Spahn was quoted by Bild.de last week with this slightly misleading statement:

Give a smile to the saleswoman in the supermarket. Give a friendly wave to the truck driver who drives goods for you day and night. And give your patience and help to those who are working under stress for your health.

So there are thanks and calls for smiles, patience and friendly waves, a "getting together" with the "little people" who keep the shop going. "We", again and again "we". Sending the dubious message from luxury to wood: We're all in the same boat. Or, in the words of the Chancellor on Sunday night:

This sense of community, this "we stand up for one another" will carry us through this difficult time.

What does not exist, on the other hand, is a debate about how it can be that those who are really relevant to the system only earn a fraction. A minimum of what the so-called elites go home with. Those people who often do their work under the most difficult conditions and yet often struggle to make ends meet. And above all, how these sad circumstances could be fundamentally changed. With our government there will probably be neither such a debate nor any change in these unfair circumstances. A smile will have to do.

Considerations on the corona crisis

The spread of the coronavirus puts the world in a state of emergency. In this country, too, nothing has been the same for weeks. The crisis is becoming a stress test for the world! The last few weeks have also provided the best visual instruction on how our system and all of us deal with abnormal situations. A subjective, tabular assessment of the situation.

In the Federal Parliament, SVP representatives Magdalena Martullo-Blocher and Thomas Aeschi were the first to warn at the beginning of the March session. The time of maneuvering criticism and unsparing consequence drawing will have to come. But a nation that sees itself as a community of destiny also knows the time of standing together. Many so-called angry citizens, whose approaches we otherwise often consider justified, do not know such a sense of honour. The lack of a sense of virtue is no longer a question of age - even the baby-boomers have never had to experience significant profile-sharpening crises.

Is the change of opinion coming?

Keeping our distance - why do we always only heed this guideline in crisis situations? If the strengths of the nation state, which is capable of taking action, protects its national borders and looks first for the benefit of its own population (and otherwise "keeps its distance"), were to receive widespread attention again, this would be one of the few positive consequences of the corona crisis. It is quite realistic that current experience could have an impact on the political priorities of the population. If it is serious, it is better to support those whose DNA has always stood for the values that Switzerland now needs. Let us be curious to see whether the change of opinion in the SVP's delimitation initiative can already secure a yes.

Crisis prevention

"Hamster shopping" has the potential to be voted un-word of the year. Those who currently hoard toilet paper en masse are probably the same people who otherwise shop abroad and frequently ask for free articles at trade fairs. Anyone who has kept their wits about them over the past few years has long been aware of the importance of intelligent crisis prevention. In times of need, we do not survive with toilet paper, but with personal provision and easily accessible, non-monetary means of payment (insider tip: spirits!). And yet only very few of us are really prepared should day X actually break out. After all, who has their own water supply and sufficient diesel generators in the house?

The real super disaster would only occur anyway when the masses panic due to power cuts and can no longer distract themselves with their entertainment devices. Or when the trucks stop running due to lack of fuel and the shopping centres are empty. The warehouses of Migros, Coop and their partners are practically only on the streets - perhaps it is time to correct this dependency too?

From false friends

In adversity you recognize your friends: The fact that France and Germany blocked the import of already paid protective masks into Switzerland casts a bad light on the EU, which is signalling: When it comes down to it, we look to ourselves first. Let's remember these "unfriendly gestures" and throw them into the balance when the political class tries to talk us into the EU framework agreement again.

It is illuminating to see how uncompromisingly states look to themselves, which otherwise appeal to the (financial) solidarity of others at every opportunity. To prevent the virus from spreading, many African and Arab states have imposed strict entry bans on Europeans. Only we Swiss waited for weeks with such logical steps - until the neighbouring countries presented us with decided facts and closed the borders to us ...

Talking about viruses: In view of the virus defence measures taken by Africa, will the taboo subject that has been taboo up to now, namely that diseases that have long since become extinct in Europe (scabies, cholera, etc.) have been reintroduced by African migrants, gain more attention? There is nothing to be said against retaliating for the same thing with the same

Support "little ones"

There is probably no alternative to the fact that the Confederation, sovereignly announced by Federal Councillor Maurer, has now created instruments to provide our SMEs with cash injections in an uncomplicated manner. If the big banks have already been saved with billions, no one today would understand if "the small ones" were left behind. However, an important reservation must not be allowed to fall by the wayside: It is unacceptable that the many solid companies that have managed to build up reserves in recent years should be able to bridge the months of crisis with their own resources and that less solid price-cutting measures by the state should not be able to fill the hollow

I can make a hand. Let us trust in Federal Councillor Maurer's foresight to push through a fair solution. Despite all the uncertainties that these days cause, is there any reason to hope that people will concentrate more on the important things in life? Certainly - we must not let anyone or anything take away our confidence. A fifth term for Merkel? How the mainstream enthuses about the chancellor

Bild und Tagesthemen are impressed by the Chancellor's crisis management - and by the high level of support for her, which the media themselves have brought about. In the Corona crisis there is even less evidence of critical support for government policy than usual.

Bild.de, the online portal of the tabloid Bild, which likes to spread false reports about RT Deutsch, published an article with the headline on Friday morning: "Chancellor Angela Merkel - 5th term of office because of Corona?"

In his play, the author effusively praised the Chancellor's crisis management in the Corona crisis. Even in quarantine, she holds the strings firmly in her hand:

Even harsh critics in the Union admit internally: it is doing a good job. Sober, experienced and familiar with all actors at home and abroad. I'm glad we have her,' says even a CSU man who has fought many battles with Merkel.

This alleged strength of the chancellor is contrasted with the weakness of the candidates in the struggle for the CDU presidency. It is argued that this constellation could result in another term of office for Merkel in the chancellorship:

So if the CDU power struggle for the presidency and chancellor candidacy remains stalemate, the party conference in December could be a hot topic: Angela is without alternative and goes into extra time!

At least the text then still mentions that the chancellor has ruled out a further term of office. And the fact that a possible end to the euro as a result of the economic collapse of the southern European states caused by the Corona crisis could cause the Chancellor to withdraw prematurely is another argument with which Merkel's new term of office is presented as unlikely.

The Bild article then praises Bavarian Prime Minister Markus Söder as the Union's possible candidate for chancellor. It is interesting to note that in this article, at least, Bild has disdainfully dropped its old favourite, the former Blackrock man Friedrich Merz, in favour of Söder.

Chancellor Merkel is experiencing a level of support in the Corona crisis that has not been seen in years. She should not, however, rest on her laurels, @koehroliver commented. #tagesthemen #Commentary Not only Bild.de praises the chancellor in the highest tones. A commentary in the ARD-Tagesthemen on Thursday hit the same mark. The MDR editor Oliver Köhr was almost overwhelmed with enthusiasm. The Union is moving towards the 40 percent mark again - and that thanks to Angela Merkel:

The Chancellor is experiencing a level of interest that she has not seen in years. Things have been looking up since she gave up the tiresome party work, but in the Corona crisis she can and must make politics as Merkel is: Drive by sight, don't draw the big lines, but work it out step by step, one by one, reassessing the situation every day. (...) Crisis management à la Merkel contributes to reassurance.

Basically, such comments and articles describe a circular argument that ignores the role of the media. At first, the media mainstream reported almost uncritically on the crisis management of the German government. Then it is surprised by the great approval of the public, which was also brought about by its own reporting, and makes a topic of it.

There are certainly good reasons for criticism of the government's crisis management: in the early stages of the crisis, the downplaying of the danger and failure to procure protective materials; later, the imposition of drastic measures for the general public with fatal economic and social consequences - and with considerable restrictions on basic rights. The media did not question the sharp change of course, but tacitly followed it through.

There was and is little to see and read about critical arguments in the news and daily topics as well as in pictures. This is one reason why there is no open debate. In the crisis, the mainstream media only act as the government's announcement and confirmation body. The latest hymns of praise, which turn a seemingly driven head of government into a strong crisis manager, confirm this once again impressively. "Degrading": Media about "pseudo-help" in Moscow and passionate appeal of an East German

"Selfish!" German media denounced Russian aid in Italy. Some in turn provided a constructive assessment of the "political signal" of President Vladimir Putin. Uwe Trostel, an East German and Berliner, sees cynicism in the situation, but also great chances for a normalisation of the EU-Russia relationship.

The President of the EU Commission, Ursula von der Leyen, scoured the national egotism of the member states in the Corona pandemic with moving words on Thursday in the EU Parliament. Although she announced the joint ordering of medical products and the establishment of a strategic reserve for all EU countries, a common line has yet to be drawn. After all, what is at stake is a stable debt instrument that would ensure the long-term financing of measures. "If you are offering me this, then we would rather do it alone," Italian Prime Minister Giuseppe Conte reacted at the EU special summit to the credit offer under the old European rescue umbrella, the news agency ANSA reported. However, he agreed to a compromise and may hope for new proposals for help in two weeks.

Russian aid to Italy:

Russian ambassador responds to accusations of "billing"

As long as this affair with Brussels drags on, it seems that Moscow is moving that fast. On 21 March Conte telephoned Russian President Vladimir Putin: it was agreed to work closely together in the fight against the coronavirus. The very next day, the first planes with protective equipment, mobile supply stations and disinfectants landed in Italy, accompanied by eight brigades of medical specialists - all provided by the Ministry of Defence - which was helpful in terms of time. Not only the Minister of Defence Lorenzo Guerini, but also several ordinary Italians subsequently thanked Russia in social networks.

However, several German-language media saw things differently

"The mainstream's comments on the Russian aid are cynical, degrading and of course carried by the ideology that only evil can come from Russia," Uwe Trostel, deputy head of the Association for Life Storytelling and Remembrance in Berlin and former member of the GDR planning commission, communicated his indignation towards Sputnik.

An article in the "Berliner Zeitung" under the title "Cosmetic Disease Control" had particularly annoyed him, so that he wrote a letter to the editor. In the mentioned article, author Stefan Scholl reiterates a corresponding judgement of the European Foreign Service that the Kremlin is sowing mistrust against national and European authorities and health care systems by disinformation about the corona virus or "conspiracy theories about global elites". The virus is presented to the Russian public as a form of foreign aggression, Scholl claims - again without precedent. The main thing is that Brussels doubts "Moscow's selflessness" - without seeing the benefits.

By the way: "Russia is sending soldiers," the news reported ironically. "Europe is losing the battle of the Soviet Union," wrote Der Spiegel. Russia and China are propagandistically exploiting the gap. And to top it all off: The Bild even drew a connection between the "pseudo-hil-worthy"

fe" of Moscow and the tricks of the Italian or German right. However, there are also more friendly voices. "In fact, the aid convoy is an extremely important signal of international solidarity in times of crisis, when national egoism - even within the EU - is regaining strength," writes the newspaper. But most of the media agree on this, regardless of the tone: With this gesture Russia is also sending a political signal. Trostel sees this as both a signal and an opportunity.

"Would it not be appropriate, especially in view of the Corona crisis, to consider a new relationship with Russia in the interests of all of us," he appealed to the media landscape.

Trostel believes that Russia's intervention in Italy could also be seen as a signal for improved relations with the West if it were able to be assessed without deep-seated reservations. He continues: "If one has not completely succumbed to the ideology of some politicians or the mainstream, would it not be time to consider that Russia, with its aid, also wants to send a signal to finally normalize its relations with Western Europe? In the past, the Russians would also have sent out enough signals for a new round of disarmament. "Far-reaching disarmament would be the imperative of the stunt, a requirement of Corona and of the climate crisis that will remain with us in the long term," Trostel wishes. He pointed out that Russia has been striving to maintain close relations with Western Europe at least since Peter the Great. In Italy, for example, people still remember the help of Russian seamen: they came to the rescue of the Sicilian city of Messina when it was shaken by an earthquake and a tsunami in 1908. Unselfishly.

Is Russia doing everything right in Corona crisis? Expert draws comparison with Germany

A few days ago North Rhine-Westphalia, Lower Saxony, Saxony, Hesse and Berlin agreed to take in a few dozen seriously ill Italians. The air force is now also flying Italians suffering from Covid-19 to Germany. Previously, only hundreds of thousands of protective masks had been delivered to Italy from Germany - keyword "exported". EU Health Commissioner Kyriakides thanked Germany in particular for "a strong demonstration of European solidarity". The President of Lombardy, Attilio Fontana, also defended the Russian mission in Italy following reports in the Italian media. These were political polemics in which he did not participate. "I would like to thank the Russians who sent us doctors and other people who may be involved in the disinfection," Fontana said in a video conference on Thursday evening.

Help from the military in times of crisis not a novelty

The tasks of the Russian medical and nursing teams in Bergamo were clarified on Thursday. Starting today, Friday, they will treat patients in 65 boarding houses. For each of the eight teams, seven to nine facilities will be assigned to help elderly corona infected persons. Other specialists will disinfect all health facilities and urban infrastructure of Bergamo, including public transport, with the supplied technology and dry steam.

Russia, for its part, is literally arming itself for the fight against the epidemic: medical capacities of the army, including military hospitals, are also being prepared to receive the sick - as an addition to, not a replacement for, the actual clinics. Nothing unusual, because the military is also being mobilised in France, for example for the operation "Resilience" (Resilienzen). The army is thus to perform tasks in the areas of health and logistics and ensure the protection of facilities relevant to the system. According to "Spiegel", the Bundeswehr, too, is to provide 15,000 soldiers to support the civilian authorities by 3 April at the latest.


